The Canada Elections Act limits the combined amount that may be donated to Eglinton-Lawrence CPC EDA (the riding association) or its candidate to \$1500 in total in any calendar year. A similar amount (\$1500.00) may also, in addition, be donated to the national party (the Conservative Party of Canada) in any calendar year. Cash contributions in excess of \$20 will not be accepted. Tax receipts can only be issued in the name of the contributor and the contributor is considered to be the holder of the credit card or the signatory on the cheque. Please note that contributions from corporations, labour unions or associations, and unincorporated associations are prohibited. Please ensure you are using a personal credit card or chequing account.
